## PURCHASE AGREEMENT

This contract serves to protect both **Giovanna McClelland** (hereafter referred to as the BREEDER), and \_\_\_\_\_ (hereafter referred to as the BUYER). Its primary existence is to safeguard the health and welfare of the said PUG.

This PUG is to be transferred to the ownership and care of the BUYER/S for the sum of \$\_\_\_\_\_. C.K.C. registration papers will be forwarded as expediently as possible.

If the BUYER is unable to, or no longer wishes to, keep this said PUG, the BUYER is to return the said PUG to the care and ownership of the BREEDER, along with signed registration papers, with NO financial reimbursement.

If the BUYER has contracted to purchase a puppy from the BREEDER, and later changes his/her mind about taking possession of the said puppy, the BREEDER will refund the purchase price LESS the deposit of \$500.00, and that will be in all cases..

**The only time the BREEDER will refund the \$500.00 deposit is if the puppy dies before delivery.**

This contract is **not transferable**, and the PUG cannot be transferred to a third party without the BREEDER's consent.

The provision of optimum conditions for the PUG in the form of nutrition, vet care and environment, become the responsibility of the BUYER.

The PUG is not to be allowed to run at large, left unchained/tied as a substitute for safe and proper kennel/yard facilities, and shall never be denied participation in the family.

The BUYER agrees to take all the steps and processes necessary to maintain this PUG as a good and well-mannered canine citizen through proper socialization.

The BREEDER transfers this PUG in a state of good health, and with current health/vaccination records. It is recommended that the BUYER have the said PUG examined by his/her own veterinarian within 48 hours of the PUG's arrival.

The PUG is guaranteed to be free of any debilitating hereditary life-threatening defects; should anything of this nature arise, the BUYER may approach the BREEDER for a replacement PUG at no charge.

**This will only be the case, provided the defect has been verified by tests, and documented by a certified/qualified veterinarian, before the PUG reaches twelve (12) months of age.**

In no case will the BREEDER refund the purchase price; it will be a replacement PUG only.

**CONTRACT OPTIONS: CIRCLED EITHER A, B, OR C by the BREEDER; to be signed and initialed by both the BREEDER and BUYER/S.**

A) **This PUG is being sold and represented as a COMPANION ONLY**, and as such, is sold on a **NON-BREEDING CONTRACT**. With the interests of maintaining and protecting only the highest quality in the breed, this PUG is NOT represented as a show/breeding quality animal. All puppies are neutered/spayed before they leave our premises.

B) **While this PUG is being sold primarily as a companion**, if the BREEDER feels this PUG shows sufficient promise at a certain stage of development for the purpose of showing and exhibiting, **this may be suggested. (The PUG would still be sold on a NON-BREEDING contract)**. This does not mean that this PUG is a guaranteed Best-In-Show dog, but simply states that the BREEDER feels this PUG shows good potential and will not discourage the BUYER from showing the PUG. It is agreed that once the prospects of further showing are no longer viable, the PUG will be neutered/spayed and retired to the home at which it is living. If the PUG has been shown to its championship or to an obedience degree, the BREEDER will **(at no cost to the BUYER)** lift the NON-BREEDING CONTRACT. **The BREEDER has the right to use this PUG for (NO EXTRA CHARGE TO THE BREEDER) breeding at any time.**

C) **This PUG is being purchased for showing/exhibiting, and as a breeding animal.** The BREEDER feels that this PUG shows sufficient promise at this stage of development for these purposes. This does not mean that this PUG is a guaranteed Best-In-Show dog, but simply states that the BREEDER feels this PUG shows good potential at this stage of development. Both parties, on a continuing and regular basis, will evaluate this PUG's quality. The BREEDER reserves breeding rights, to their own PUGS. When the BREEDER uses the PUG, it is the BREEDER's responsibility to receive the PUG from the BUYER, and send the PUG to the BUYER. The BREEDER reserves the right to have a puppy from any litter (for future blood lines) that is sold from our breeding stock. **This not to say it will be done, but that there is a possibility. The PUG will not be sold on a NON-BREEDING CONTRACT.**

Again, the health and well-being of the said PUG is to be the primary goal in all things. **If the BUYER disregards any part of this agreement, as it pertains to the safety, care and welfare of the PUG outlined in this contract, the BREEDER shall request that the BUYER ADDRESS ANY SUCH CONCERNS IN A SATISFACTORY MANNER. If this is not done in a reasonable amount of time, THIS PUG WILL BE CONFISCATED / RECLAIMED (BY THE BREEDER) WITH NO FINANCIAL RECOMPENSE TO THE BUYER.**
